Item 12.A. High School Facilities Needs Assessments and Master Planning Update – Villa Park High School

Principal Ed Howard introduced the item and spoke about the need for facilities improvement at Villa Park High School.

At the November 15, 2012 Board of Education meeting, staff was directed to procure facilities needs assessments for each of the District's four comprehensive high school campuses and report the findings to the Board.

At the June 6, 2013 meeting, the following four firms were selected and approved by the Board to perform the facility assessment analysis and master planning for each of the four high schools.

- Lionakis Orange High School
- gkkworks Canyon High School
- Harley Ellis Devereaux El Modena High School
- LPA, Inc. Villa Park High School

The Board received information from the architectural firm, LPA, Inc., regarding the master plan development process and the outcome of such a process for Villa Park High School.

Speakers

Scott Carbaugh, spoke in support of the bond and posed the question to the Board, "if not now, then when?"

Erik Kuli, spoke in support of bond and encouraged the Board to support a bond measure.

Linda Roslund, spoke in support of the bond and commented on the need for school repairs and encouraged the Board to put the bond measure on the ballot.

John Kulisich, spoke in support of the aquatics program and student athletes. He supports a school bond and hopes to see a new aquatics facility at Villa Park High School.

Joe Greenwald reflected on the significant steps that have taken place over the last year that hopefully will lead to improved facilities for the District. He noted that the progress made is exciting, but more needs to be done. He stated that there is a formal organizational structure for CARE and volunteers are ready to support a school bond. He asked for continued unified support from the Board and asked that a bond measure be placed on the ballot to give the community an opportunity to show support for their schools.
